Deposit: 20% of the contract amount (rounded) is required to secure services for any specified date and event. If for any reason, the client should cancel, the deposit is non-refundable. Deposit may be used towards the balance of a future function within 3 months of the original event date, subject to availability on **SnazzyBeatz's** event calendar.

Contract Balance: The contract balance **MUST** be paid soon after the DJ/MC services are delivered, on the day of the event or when the DJ arrives at your event. Please have the payment (check or cash only) available during your event. Client agrees to pay a \$100 penalty fee for a bounced check. **Payment may not be made at a later date.** If the client does not have payment available on the date of the event, a late fee of \$100 will be paid by the client.

Music and equipment: Each contract will include ONE set of comprehensive DJ gear unless otherwise specified in the additional adjustments below. Additional set up requirements for ceremony and or procession coverage, a second room/venue set up will be charged additionally. Specific music choices, if any and the program layout must reach **SnazzyBeatz**, two weeks prior to the event so as to allow us sufficient time to work on it, failing which, the availability of the requested music is not guaranteed.

Hours: For any extended hours beyond the timings mentioned in this contract, the customer agrees to pay additional charges, quoted as \$100 per hour. The contract amount may not be adjusted under any circumstances after it has been signed.

Mileage: The client agrees to pay for driving time and mileage (\$0.50/mile) for an event that is outside the Detroit Metro Area (defined as beyond 50 mile radius from **SnazzyBeatz's** address). Overnight accommodation might have to be provided if, the venue is beyond 50 miles, based on your DJ's preference for the specific event.

Neither **SnazzyBeatz** nor any of its associates shall be held liable for any loss or liability, as a result of the services performed.
